### Our Structure and Business

While Richard Wolf UK's turnover is under £36 million, Richard Wolf GmbH has a global turnover exceeding £36 million and conducts business in the United Kingdom. Accordingly, Richard Wolf GmbH is subject to the Act, and this statement applies to Richard Wolf UK as part of the wider Richard Wolf group.
